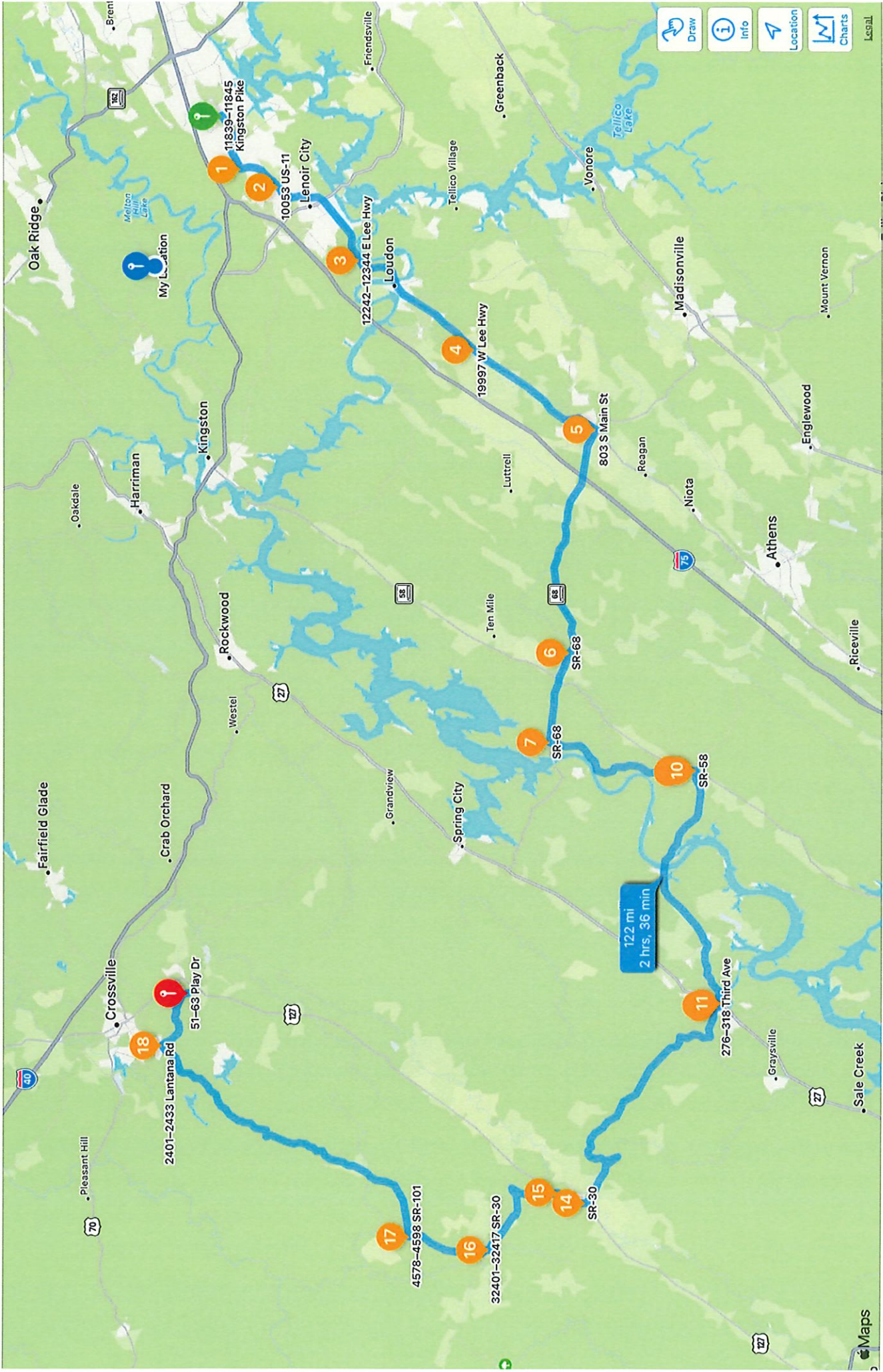

1	When leaving Village Green Shopping Center turn right onto Kingston Pike	0
2	Proceed along Kingston Pike to traffic light at Hwy 11.	4.1
3	Turn left onto Hwy 11	4.1
4	Proceed along Hwy 11 to Sweetwater. You will pass through Lenoir City, Loudon, and Philidelphia. In Sweetwater, proceed to traffic light at intersection with Hwy 68 (Walgreens will be at intersection on right).	29.5
5	Turn right onto Hwy 68.	29.5
6	Proceed to Hwy 68 to River Road (Hwy 304).	47.3
7	Turn left onto River Rd.	47.3
8	Proceed along River Rd to Decatur. Just before the Stop sign at the intersection with Hwy 58 turn left into the Piggly Wiggly parking lot for a rest stop.	56.1
9	Upon leaving the Piggly Wiggly, turn left onto River Rd and proceed short distance to a Stop sign at Hwy 58.	56.2
9	Turn right onto Hwy 58.	56.2
10	Proceed short distance to traffic light at intersection with Hwy 30.	56.5
11	Turn right onto Hwy 30.	56.5
12	Proceed along Hwy 30 to traffic light at intersection with Hwy 27 in Dayton. Proceed through traffic light.	70.9
13	Proceed to traffic light at intersection with Market Street. Rhea County Court House will be diagonally across the street.	71.2
14	Turn right on Market St.	71.2
15	Proceed short distance to traffic light at intersection with Hwy 30. Coulter Garrison Funeral Home will be on the right.	71.3
16	Turn left onto Hwy 30.	71.3
17	Proceed on Hwy 30 to intersection with Hwy 127 in Pikeville.	88.4
18	Turn right onto Hwy 127N.	88.4
19	Proceed on Hwy 127N to intersection with Hwy 30 (just beyond McDonalds on right).	90.1
20	Turn left on Hwy 30W	90.1
21	Proceed on Hwy 30W to Hwy 101N. (there will be a 3-Way Market & Bledsoe Co Fire Dept on right).	97.2
22	Turn right onto Hwy 101N.	97.2

23	Proceed on Hwy 101N to junction with Hwy 285W.	101.8
24	Turn right onto Hwy 101N to Crossville.	101.8
25	Proceed on Hwy 101N to Hwy 419S.	120.6
26	Turn right onto Hwy 419S and proceed to Cumberland Mountain State Park.	120.6
27	Within Park boundary, turn right at Stop sign onto Play Dr. Homestead Harvest will be on the left.	124.2
