1	Kingston Pike. Proceed along Kingston Pike to traffic light at	0
2	Turn right onto Everett Rd	2.5
	The next turn will be right. Proceed along Everett Rd to	
	interesection with Watt Rd (Flying J Truck Stop on right at this	
3	intersection). At intersection, turn right onto Everett Rd.	6.1
	Proceed along Everett Rd noting that at 6.9 miles the road's	
	name changes to Buttermilk Rd. Bear left to stay on Buttermilk	
4	Rd.	6.9
	The next turn will be right. Proceed along Buttermilk Rd to	
	intersection with White Wing Rd N. Turn right onto White Wing	
5	Rd N.	12.7
	The next turn will be right. Proceed on White Wing Rd N just a	
	short distance to Stop sign at intersection with Hwy 95. Turn	
6	right onto Hwy 95.	12.8
	Proceed along Hwy 95 to interchange with Hwy 58. Move to left	
7	lane and proceed onto entrance ramp for Hwy 585, Kingston	19.1
	Merge onto Hwy 585 and proceed short distance to traffic light	
	at intersection with Blair Rd (Hwy 327). At this point, turn right	
8	onto Blair Rd Hwy 327N).	19.7
	The next turn will be right. Proceed along Blair Rd to Old	
	Harriman Hwy. There will be a brick mini storage building with	
	white garage doors at this intersection. Bear right onto Old	
9	Harriman Hwy.	23.9
	The next turn will be right. Proceed on Old Harriman Hwy to the	
	town of Oliver Springs. Note that within town, Old Harriman Hwy	
	transitions into W Rd and then into Kingston Avenue. Proceed to	
10	Stop sign at intersection with Main St. Turn right onto Main St.	31,3
11	Proceed along Main St and merge left onto E Tri County Blvd (TN	
11	62)	31.7
	The next turn will be left. Proceed on E Tri County Blvd to	
	traffic light with Food City on left. Get into left turning lane and	
12	turn left into Food City parking lot for a brief rest stop.	32,3
13	Depart Food City by turning right back onto E Tri County Blvd.	32.4

14	The next turn will be right. Proceed along E Tri County Blvd to traffic light at intersection with Hwy 62. Turn right at traffic light.	33.6
15	The next turn will be left. Proceed along Hwy 62 to Back Valley Rd. As a reference, Middle Creek Baptist Church will be on the right. Turn left onto Back Valley Rd.	35.8
16	The next turn will be left. Proceed on Back Valley Rd to Stop sign at intersection with Coal Hill Rd. Turn left onto Coal Hill Rd.	39
17	The next turn will be left. Proceed along Coal Hill Rd to intersection with Morgan County Hwy (Hwy 27). Turn left onto Hwy 27.	44.6
18	The next turn will be left. Proceed on Hwy 27 to point where Hwy 27 and Hwy 61 merge. Immediatley afer merge, get into left lane and turn left into access lane for Hwy 61E.	46.4
19	Turn left onto Hwy 61E and proceed on Hwy 61E to Little Emory Rd on right. Turn right onto Little Emory Rd.	47.5
20	Proceed on Little Emory Rd, bearing left onto Clax Gap Rd.	48.1
21	Proceed on Clax Gap Rd to Y just beyond Clax Gap Baptist Church. Bear right onto Dickey Valley Rd.	50.1
23	The next turn will be right. Proceed on Dickey Valley Rd to Stop sign at intersection with Sugar Grove Valley Rd. Turn right onto Sugar Grove Valley Rd.	53.3
24	The next turn will be left. Proceed on Sugar Grove Valley Rd into Kingston. Upon entering Kingston and traveling under I40, proceed to the 5th traffic light at Hwy 70. Turn left onto Hwy 70.	570

25	The next turn will be left. Proceed along Hwy 70 to Red Heaven Ranch at 614 US Hwy 70 on left.	70.8
